The 2017 Annual Meeting of Shareholders of Itron, Inc. (the "Company") will be held on May 12, 2017 at the Davenport Hotel in the Porter Room, at 10 South Post Street, Spokane, Washington 99201, at 8:00 a.m. (local time).

Proposals to be considered at the Annual Meeting:

- 1. to elect four directors to the Company's Board of Directors;
- 2. to hold a non-binding advisory vote on executive compensation;
- 3. to hold a non-binding advisory vote on how often a non-binding advisory vote on executive compensation should be held;
- 4. to approve the Itron, Inc. Second Amended and Restated 2010 Stock Incentive Plan, including to increase the shares authorized for issuance thereunder and approval of the material terms required under Internal Revenue Code Section 162(m);
- 5. to ratify the selection of Deloitte & Touche LLP as the Company's independent registered public accountant for the 2017 fiscal year; and
- 6. to transact such other business as may properly come before the meeting or any adjournment or postponement thereof.
