## **Itron Secures Contract with Questar Gas to Upgrade Metering Infrastructure**

*Utah-based utility to use Itron technology to improve operational efficiency and customer service*

LIBERTY LAKE, Wash.--(BUSINESS WIRE)-- Itron, Inc.
